



# Annex to Mid Term Financial Forecast Paper: Public Consultation on the Council Tax Precept 24/25.

**Date:** 31.10.23

#### **BACKGROUND/CONTEXT:**

This document provides a draft of the precept consultation questions we plan to promote to residents during December and January.

The consultation text aims to explain the rationale behind the Mayor's decision on next year's precept level, and collect residents' feedback on this proposal.

#### **CONSULTATION PROGRAMME:**

This year's public consultation will repeat the methodology used for last year's programme of consultation, and include:

- Our usual online consultation survey,
- A postal survey, mailed to a randomly selected sample of West Yorkshire households.
- Face to face consultation events arranged across West Yorkshire districts by the Policing and Crime Engagement Team.

Last year's precept consultation attracted 1,700 responses from residents, with 69% supporting the Mayor's proposal for the precept in 22/23. This represented an increase in support levels on the previous year's consultation (62% supported of the proposal for 22/23).

The hybrid approach of online survey, postal survey, and focus-group consultation provides options for different communities to engage with the consultation. It mixes the convenience of an online survey (easily promoted, and simple for residents to complete), with a randomly selected sample of households contacted through the post.

Face-to-face consultation events will be held in each of our five districts during November and December. Promotion of these events also helps to raise wider awareness that the consultation programme is underway. We will also use these sessions as a first step in collecting residents' opinions on wider community safety issues in preparation for developing the next edition of the WY Police & Crime Plan. The postal survey will contact c.7,000 randomly selected households; this reflects a sample size which will achieve sufficient responses for a 95% confidence level on the result.

#### **CONSULTATION QUESTION:**

The consultation uses the format taken in previous years, with a page of commentary on the background behind the Mayor's decision to consult, followed by two simple questions to gauge residents' views on the precept proposal.

#### **EQUALITY, DIVERSITY AND INCLUSION BENEFITS AND IMPLICATIONS**

Through the programme of focus group events, we hope to reach out to communities and individuals who may struggle to respond to an online survey, or whose feedback can be under-represented in consultation surveys.

The attached questionnaire also includes the range of questions we will ask to evaluate the responses of those from different groups with the West Yorkshire population.

#### PROSPOSED CONSULTATION TIMELINE:

We plan to launch the postal and online consultation during December, with face-to-face consultation events starting during November. This will be accompanied by promotional work utilising the local press, online, and social media channels.

The results of the consultation will be shared with the Panel in the February 2024 meeting.

The following pages provide a draft version of the consultation questionnaire based on last year's online survey. Please note that the introductory text and precept value table will be updated once the 24/25 budget requirements are finalised. The core consultation questions are in section 1 of the document. Section 2 covers questions on respondent's personal characteristics. In this document, they are presented in full, however when individuals take the survey, they will only view aspects of the survey relevant to themselves (i.e. an Asian/Asian British respondent will only see the full list of Asian ethnic groups).

#### **Consultation Text – draft version**

Dear Resident.

As Mayor of West Yorkshire, I am responsible for setting the annual budget for West Yorkshire Police. This includes agreeing the local 'police precept' - the part of the Council Tax that helps to fund local policing.

Every part of the country relies on funding gathered through Council Tax payments to support their local police force. The cost of the police precept in West Yorkshire is actually the fourth lowest in England and Wales, but it still provides 28% of West Yorkshire Police's total net annual budget, with almost all of the remainder coming from central government funding.

West Yorkshire Police's dedicated staff are working across our districts each and every day. They work in an increasingly complex world, with today's police officers needing to prevent crime, tackle criminals, and safeguard vulnerable people, not just in our neighbourhoods and communities, but also online and in places away from the public's view.

Through this consultation, I am inviting residents to give me their views on funding our local police service in the year ahead.

Funding gained through the police precept will help us to maintain the just, safe, and inclusive police service we need. Without this support, we will face severe pressure on the police budget.

This year the Government has announced that a precept equivalent to an annual £15 increase on Band D households can be set. The table below describes what these changes would mean for the cost of the precept as part of your Council Tax bill.

Most West Yorkshire residents live in properties in Council Tax Bands A, B or C, and under these proposals the extra cost for these households would be between 19p and 26p per week (a 6.78% increase on last year). If you do not pay Council Tax then nothing will change, and you will not pay the police precept next year.

Without raising funds in this way, we can expect that West Yorkshire Police will need to cut costs across its operations, which will mean making difficult choices about which services to communities they will need to focus on, and which will need to be cut-back.

I want to maintain and support these levels of service in the years ahead, and so once again I would like to ask your opinion on our proposals with two questions on the following page. I have also provided a short table showing the weekly cost to residents for the different Council Tax bands.

Please remember that if you do not pay Council Tax now, then you will not pay
