



Precept Consultation 2023/24 Final Results

Our public consultation on the Mayor's proposal for the Council Tax police precept ran between the 16th of December 2022 and 16th of January 2023.

Residents were invited to respond to the proposal of a 6.78% increase, corresponding to 29 pence per week extra for a Band D property.

The consultation was promoted extensively online through the Mayor's and Deputy Mayor's Twitter and Facebook accounts, through the Combined Authority's 'Your Voice' consultation platform, and also circulated to our partners to help reach a wider audience. This year we also extended our engagement through a postal survey (contacting a randomly selected sample of West Yorkshire addresses), and by face-to-face engagement through focus group events.

The Deputy Mayor for Policing and Crime also promoted the consultation during her appearance on the 'Message the Mayor' feature on BBC Radio Leeds on 8th December, and the opportunity for residents to feedback was also highlighted by the *South Leeds Life* website.

Residents were asked:

- Whether they supported the Mayor's proposal to increase the Council Tax police precept to seek the funding required to help West Yorkshire Police keep our neighbourhoods and communities safe; and,
- Whether they were willing to pay the associated increase to their Council Tax to help protect frontline policing across West Yorkshire.

By the close of the survey 1,700 residents had responded to the consultation.

Headline results:

- 69% of respondents supported the Mayor in seeking the funding required to help West Yorkshire Police keep our neighbourhoods and communities safe.
- 67% of respondents supported the proposal to increase the precept in 2023/24
- 50% of respondents were from Band A to C households, with Band D households the most frequent (22% of the total).
- 66% of residents in Bands A to C supported the precept increase; the figure was 68% for those in Band D and above.
