#### Introduction

This report aims to summarise some of the recent progress made by the Office of the Police and Crime Commissioner (OPCC), West Yorkshire Police and key partners in delivering the Police and Crime Plan. Activity included in this report covers the quarter September to December 2018, and statistics presented reflect the 12 months to December 2018, unless otherwise stated.

The report focuses on the four main outcomes of the Police and Crime Plan; tackle crime and anti-social behaviour (ASB), safeguard vulnerable people, make sure criminal justice works, and support victims and witnesses. These outcomes were decided on following extensive consultation with the public, police and partners. We cannot hope to successfully deliver these outcomes unless we all work together.

This report sets out our collective progress against each of the delivery measures, but does not contain an exhaustive list of all delivery activity. More information can be found on my website at <a href="https://www.westyorkshire-pcc.gov.uk">www.westyorkshire-pcc.gov.uk</a>.

## **Delivery Overview**

The data included in this report comes from a range of different sources including national crime statistics and surveys, West Yorkshire Police, HMICFRS inspection reports, partner performance indicators, and consultations carried out by my team. Having a mix of quantitative and qualitative measures allows me to present a more holistic and meaningful report to the public.

We also include data from the 'Your Views' survey, which was launched in June 2017 to provide data on a range of measures of public confidence and community safety at local level in West Yorkshire. The data in this report compares this quarter with last quarter.

The Delivery Quarterly report aims to provide a balanced account of police, partner and OPCC delivery over the past quarter. I hope that by including details of our progress in tackling crime and community safety issues as a collective, we can help our communities understand and be reassured by our unified approach. As I have said before, keeping West Yorkshire safe and feeling safe cannot just be left to the police.

#### Tackle crime and anti-social behaviour

Tackling crime and anti-social behaviour is a challenging and varied task. Different problems require different responses and different partner's involvement. Together with the police and local and national partners, we will continue to protect our communities by tackling the perpetrators of crime, and reducing the opportunity for crimes to occur. To understand how we can best focus our collective resources, I closely monitor crime levels, measures of public confidence, police service demand, and communities' feelings of safety, through the data in this report.

## Safeguard vulnerable people

As with all the outcomes in the Police and Crime Plan, safeguarding vulnerable people requires input from a wide range of organisations. As PCC for West Yorkshire, I have brought partners together to tackle important issues such as child sexual abuse (CSEA), support for people with mental health issues within the criminal justice system, human trafficking and modern slavery, and honour based abuse. I will continue to contribute to this safeguarding agenda by promoting partnership working, for example in our response to children who repeatedly go missing from home.

## Make criminal justice work

It is important that our communities have confidence in our criminal justice system. This report presents measures to help me assess how effectively partner organisations are working together to achieve efficient court processes, and how well West Yorkshire Police's workforce reflects the demographic profile of the local population.


## Support victims and witnesses

The OPCC supports the needs of victims and witnesses in West Yorkshire by funding key services which are delivered by partners in the third sector and district Community Safety Partnerships (CSPs). In this report, I monitor data provided by the police, our own internal research, and that of our delivery partner Victim Support, to understand the needs and experiences of victims and help me evaluate the quality of the service they receive.





#### Commentary

Recorded crime has increased by 11% when the 12 months to Dec 2018 are compared to the preceding 12 months. Just under half of this increase is related to improvements in recording practices which have taken place over the past two years. Analysis of recorded crime records shows that all of the 43 police forces in England and Wales are now showing increases in the volumes of crime that they record. The MSG average increase is now 9% in comparison with the 11% increase seen in West Yorkshire. This is the subject of regular scrutiny with the Chief Constable





#### Commentary

Reoffending rates taken from Ministry of Justice data record the proportion of offenders released in a given year who go on to reoffend in the following twelve months. Figures for the year to Dec 2016 record a reoffending rate for West Yorkshire adult offenders of 29.6%, and of 43.5% for youths. The overarching trend is a deterioration in youth reoffending rates, increasing from 38.2% in March 2013. Calderdale's youth reoffending rate is slightly higher than other districts, but the figure is affected by a small sample size. With support from my office, West Yorkshire Police has been working on developing additional ways to monitor reoffending rates.


#### Commentary

The drop in % for this measure is due to the introduction of new codes by the HMICFRS to determine the number and proportion of officers and staff in the following categories 'Visible operational frontline roles'. 'Non-visible frontline', 'frontline support' and 'business support' roles. The current figure reflects the percentage in the first 3 categories. As the country starts to use these new categories. I will look to ensuring that our frontline continues to be protected and is comparable with other forces.



#### Commentary

Through our Your Views residents survey, we ask people to assess whether they feel safe in their local neighbourhood. This quarter's results identify that (for the year to December) 79.4% of West Yorkshire residents said they feel safe in the place where they live, continuing the slight downward trend seen over the past year. Looking back over the six quarters of data we hold, responses to Your Views suggest that neighbourhood concerns about burglary, drugs, and crime in general may be influencing residents sense of safety.



#### Commentary

The response to our questions on people's satisfaction with the operation of their local police service records strong positive responses on integrity matters: whether people feel the police would treat them fairly or with respect. Weaker scores are recorded for people's expectation of whether the police would tackle the issues that matter to them, and people's overall rating of the effectiveness of their local police (shown in this chart). The West Yorkshire figure fell by a further percentage point between September and December, with Kirklees and Wakefield recording the largest reduction in scoring between the quarters.

#### Commentary

The Your Views survey asks respondents whether they feel confident that the police, local authority, and public sector partners ('community safety partners') work well together across a range of issues. At West Yorkshire level, each of these indicators has seen its positive score weaken during 2018. At district level, looking across eighteen months of data, Leeds residents are recording a reduction in people's confidence in CSP's work to keep local communities safe. Kirklees is also seeing a fall in scoring on this indicator and on protecting the vulnerable, preventing crime, and listening to the community's concerns.

## West Yorkshire Police Delivery

**Police recorded crime** increased by 13.1% in the year to Dec 2018, with our most similar neighbours seeing a similar increase. The better crime recording practices are still affecting the numbers of crimes recorded with 7% of the offences due to improved recording practises.

The unprecedented levels of **Calls for Service** are continuing with the Force responding to 170 additional calls per day compared with the same period last year. This has impacted on the ability to answer 101 calls in a timely fashion but recent efforts to improve waiting times for 101 callers including encouraging the public to contact online, are having a positive impact.

Driving improvements in the **Standards of Investigations** is central to the Forces ambitions over the coming year. The investigations review aims to embed an improved investigative culture through the delivery of newly designed training packages and by establishing important process changes in areas such as crime allocation and prisoner handovers.

There have been a number of recent notable achievements in relation to **Serious and Organised Crime** and the review of historic serious sexual offences continues to see offenders being brought to justice. In October 2018 a murderer who sparked one of West Yorkshire's biggest ever manhunts was given a whole life sentence in prison after admitting 16 additional offences including rape. West Yorkshire Police's 'Cold Case' Team – Operation Recall – led the investigation.

The Major Collison Enquiry Team have seen a number of complex enquiries come to fruition at court over the past quarter which hopefully goes some way to providing comfort to the families of deceased people and again underlines West Yorkshire Police's expertise and professionalism in dealing with often complex crash scenes and the subsequent investigation. Operation Pageabbey and Operation Plantgate have resulted in custodial sentences of four years and 16 months respectively for men who pleaded guilty to offences of causing death by dangerous driving.

## **OPCC Delivery**

In October I released my latest **Annual Report** detailing my work over the last year to help keep communities across the county safe. A particular focus for me over this last year has been the care for victims. We now have an expanded, more accessible service available to victims of all ages through the new **Victim Support** contract. We have established specialised victims hubs in each district of West Yorkshire as well as commissioning a live chat facility.

I have been pleased to support a new dedicated policing team which has been launched in Leeds to tackle wildlife and rural crime.

The Leeds District Wildlife and Rural Crime Team will work to address and raise awareness of issues including animal cruelty and poaching. It will also focus on crimes such as burglary and theft of farm machinery that affect rural and farming communities.

Tackling **serious violence** is a priority in my refreshed Police and Crime Plan and through my engagement with local communities, I have heard the truly horrendous impact violent acts can have on people's lives and those close to them. A dedicated week of action ('Operation Sceptre') to tackle **knife crime** was launched by West Yorkshire Police in September. The week included educational activities, targeted enforcement work and the promotion of strong anti-knife messages. Officers spoke during school assemblies, and joined pupils on school buses to spread the message of the dangers of carrying a knife.

In October a successful week of action took place to tackle **County Lines** in West Yorkshire. Weapons, cash and illegal drugs were seized.

Officers also safeguarded 22 **potential victims** and made 16 arrests during the operation

We looked to use the week of action as way to publicise the way criminals operate and to make sure people know how to spot the **signs of the crime**.

By knowing about county lines crime, parents and carers can increase their chances of stopping their child or loved one being taken advantage of by criminals. Follow the **#trapped campaign** on social media for more information.

## West Yorkshire Partners' Delivery

Bradford Council and its local community safety partners have worked to tackle **antisocial behaviour** and **lower level public disorder** in the run up to bonfire night. In previous years there have been a number of informal bonfires, targeted incidents of deliberate arson, and attacks on emergency services staff.

Extensive consultation was undertaken with partners, faith contacts, schools, youth and BAME groups to understand in more detail community concerns and explore a community led response.

Communities and partners discussed hotspot areas requiring attention, and this led to the development of action plans for **backstreet clean-ups**, anti-litter and no flytipping signs, **doorstep work** to help to encourage residents to responsibly dispose of their waste, and enforcement against owners of land with accumulated waste. Further **awareness work** was delivered in local schools through West Yorkshire Police's Safer Schools team.

40 Days of Action were undertaken making over 4,000 local contacts. Approximately 120 premises were cleaned or notices issued through **Council Wardens** and the **Environmental Enforcement Team**. Through improved partnership working and information sharing between Bradford Council, West Yorkshire Police, West Yorkshire Fire and Rescue Service and residents, the voluntary sector, and faith communities, there were fewer reports about bonfire related anti-social behaviour across the hotspot areas compared to the same period last year.

Also in Bradford, the Council's Area Co-ordinators' Office in Shipley is funding a **Crimestoppers** promotional campaign across the area. Working with the police, ward officers are looking to encourage residents to use Crime Stoppers to report suspicious activity in their locality.

Running parallel to the project is the promotion of the *Fearless* website, which is the **youth arm** of Crimestoppers. A Fearless **training event** will be held in Shipley in March for anyone who works with young people, to help them understand of how young people can protect themselves from risks and threats.

## **OPCC Delivery**

In November, I addressed the latest of our annual **Third Sector Conferences**. This major partnership event was themed on ways to help divert young people away from harm and potential criminal behaviour. Dozens of third sector organisations attended Leeds Civic Hall, with key speakers from the police and Youth Offending Teams, Safer Communities Partnerships, local projects and third sector advisory groups.

The themes discussed included drugs and alcohol, mental health, adverse childhood experiences, multiple and complex needs, as well as domestic and sexual abuse.

The continuing funding challenges across public sector organisations is translating to further pressures upon third sector groups, who are increasingly left to fill the gaps. Working together and forging a collective approach with early intervention and prevention at its core is crucial to providing services that deliver better medium and long term community safety outcomes.

The event followed the **successful award** to West Yorkshire projects of over £1M of Home Office funding under the 'Early Intervention Youth Fund'.

Grant Round 14 of the **Safer Communities Fund** awarded West Yorkshire Police's Kirklees Youth Intervention Team £4500 towards a project to divert secondary school students from gangs, drugs and alcohol. The project funded the 'Paul Hannaford School Tour', a presentation by an ex-offender on his 'lived experience' of drug addition, alcohol, gang life, gun & knife crime, prison life, self-harm and bullying. The project saw Paul visiting five different schools across a five day period, delivering a strong preventative message which made a big impact on students.

The **Kirklees Youth Intervention Team** was formed in September 2017 and comprises of four Police Officers with experience of work in school settings and in safeguarding roles. The aim of the team is to work with schools to identify young people aged 11 to 16 who are at risk of offending or getting involved in anti-social behaviour, gangs or going missing from home. Some of these behaviours can increase the risk of a child becoming a victim of sexual exploitation.

The team work with identified young people and their families to divert them into worthwhile activities which will benefit their future



#### Commentary

In March 2018 HMICFRS released the Effectiveness report for West Yorkshire Police which completed the 2017 PEEL assessment. West Yorkshire Police were graded as GOOD across every strand indicating that they provide an Effective, Efficient and Legitimate service to the public of West Yorkshire. The next inspection starts in May 2019.

As discussed my office now has access to the recommendations register from HMICFRS and in my quarterly meeting with the Chief Constable, we discussed the Crime Data Integrity Inspection which is currently awaiting the report from HMICFRS, the recommendations from the last Child Protection Inspection and the actions from the initial police response to hate crime report. The Force has reassured me that they are dealing with these recommendations in a timely manner and we will continue to assess the 61 actions either being progressed or awaiting review.



#### Commentary

9,639 people were reported missing in the 12 months to Dec 18 (down by 226 people on the previous quarter). The number of these missing persons that were children totalled 4,182 (43% of the total). Of those children 37.0% were children missing from Care. West Yorkshire Police is committed to working with social care agencies to help prevent people going missing, concentrating on those at the most risk. One highlighted risk is the number of small children's homes that are springing up in the area and measures to look at these are currently being discussed.

#### Commentary

Forced Marriage and Honour Based Abuse figures have now been joined into a single set of figures; this is due to there being so much overlap on them (i.e. many occurrences being flagged with both FM and HBA). Top occurrence types in the last 12 months were as follows: Domestic (154 / 38.8%), Referrals (91 / 23%), and Court Orders (61 / 15%). I am working with Safeguarding units to ensure that these crimes are properly flagged and vulnerable victims are safeguarded.

## West Yorkshire Police Delivery

The Force has received positive feedback that West Yorkshire has one of the highest **Active Risk Management System (ARMS)** completion rates nationally. This is the risk management that is completed for Sex Offenders and over the last eighteen months West Yorkshire are consistently reporting completion rates of between 93 and 95.5% which is indicative of the excellent work.

**Human Trafficking** and Modern Slavery has been identified as one of the force's top 10 strategic threats. In the last 12 months to Dec 2018, 537 offences have been recorded in comparison to 223 in 2016/17 and 371 in 2017/18. The force remains one of the **highest referrers** of 'potential victims of trafficking' (PVoTs) to the National referral Mechanism (NRM) with 100 referrals in the last 12 months.

The latest statistics with regard to **Missing Persons** indicate that the problem solving activity and partnership working is continuing to have a positive impact and the number of persons who go missing repeatedly is falling.

### **OPCC Delivery**

The Chief Constable and I backed the national **hate crime** awareness week in October Tackling **hate crime** continues to be a **focus** in my Police and Crime Plan, as well as recognising hate incidents and working with partners and communities to prevent escalation.

A host of work has been done and is on-going, I have worked with West Yorkshire Police for a number of years to run the "Hate Hurts" campaign which looks to raise awareness of the issues and how to report them. I have helped fund Victims Hubs in every district of West Yorkshire where anyone affected by crime can go and get the support they need.

I have also funded and worked with many dedicated community groups and charities who are raising awareness of hate crime, supporting victims and preventing incidents from taking place in the first place, such as **Stop Hate UK** who created a bespoke West Yorkshire free smartphone app for reporting hate crime, including lots of other useful information.

## West Yorkshire Partners' Delivery

Calderdale's CSP have worked alongside West Yorkshire Police in the run up to Christmas to keep Halifax town centre as safe as possible. Officers provided support and reassurance during late night shopping periods and festive night outs to help keep residents, retailers and shoppers safe. Crimes such as thefts and burglaries tend to increase in the winter months, and plain-clothed officers and high visibility patrols worked with retailers to help identify offenders and prevent crime.

Halifax Street Angels and Community Safety Wardens also worked to help meet the town's commitment to its Purple Flag status for promoting a safe and clean town centre.

**Neighbourhood Policing Teams** also worked with council officers to conduct licencing checks of premises and clamp down on underage drinking. **Crime prevention** events were held in Brighouse, Todmorden, Hebden Bridge and at Southgate in the town centre. Officers also continued their work on **roads policing** as part of Operation Hawmill - Calderdale's dedicated road safety operation.


## **OPCC Delivery**

I visited **Castleford** recently to see how a local **Neighbourhood Policing** initiative is making a difference to **vulnerable people's** lives. £2,430 of SCF funding was granted to a project called "Street Safe", which looks to **give crime prevention packs** and advice to support those in need, such as **homeless people**, **vulnerable adults** and the **elderly**. The packs are tailor-made for the individual, but can contain a variety of resources, including defender wrist alarms, emergency 'space blankets', high visibility bags and thermal clothing.

In March I am inviting victims, survivors, witnesses and people who have directly been affected by crime and anti-social behaviour in West Yorkshire to an event in Leeds to learn more about their experiences. Many of the crucial decisions affecting victims (such as court closures) are made at national level, and I want to hear people's views to inform my discussions with decision makers through the Association of Police and Crime Commissioners. I am committed to consulting directly with those who feel the impact of crime, as we develop our own West Yorkshire approach to these concerns.



#### Commentary

The Your Views survey includes a series of questions focused on the work of community safety partners, such as CSPs, the police, fire and probation service. This indicator reflects residents' views on whether they feel partners listen and respond to communities' concerns; as with other CSP indicators, the positive score has fallen slightly over the past year. Across West Yorkshire, 45.0% of respondents said they agree with this statement (data for the year to Dec. 18), down from 47.2% in June. Notably there has been a reduction in positive scoring in Kirklees and Leeds on this measure over the past eighteen months.

## Objective: Ensure relevant partners are working together to achieve effective and efficient results




#### Commentary

The ineffective trial rate at Magistrates Courts (black line) has been maintained over the last year, surpassing the ambition of an effective trial rate of 85% (ineffective below 15%). Currently the figure stands as 13.6% for this guarter, but the figures are only up to November 2018.

The time taken for cases to be brought to resolution at Magistrates Courts (blue line) has stabilised with the latest figure as 50.5 days a 0.3 decrease on the previous quarter. This data is up to Sept 2018.

With regard to the improvement in the ineffective trial rate, long term improvements are being driven by the Transforming Summary Justice project and improved case management at court, with the direction from District Judges at case management stage, which has led to fewer cases sent to trial. There is also better communication between the CPS and defence due to the early provision of summary disclosure which prevents issues being raised at the last moment.

### Objective: Have a police service which is more representative of the people it serves



#### Commentary

The proportion of the police service in West Yorkshire from BME communities has increased gradually over the past few years, from 5.2% in Dec 2015 to 5.6% in Sept 2018. Since April 2016 there have been a total of 3,192 joiners to the organisation and 6.6% are from a BME background.

### West Yorkshire Police Delivery

April 2018 saw the launch of a new model for neighbourhood policing in West Yorkshire, backed by my decision to invest in frontline policing. A formal review of West Yorkshire Police's **neighbourhood policing** will be conducted from March 2019, when the model has been in place for 12 months. This will enable the force to establish if there is any need for change. WYP are currently conducting **PCSO workshops** across all districts to gain their views on how their role can be enhanced further.

The **Neighbourhood Teams** continue to use and grow their **social media platforms** to raise awareness, **offer advice** and keep the public **engaged and updated**. Some Neighbourhood Teams are now delivering **newsletters** to their communities to keep them informed of the work being undertaken in their areas.

It has been agreed that each Neighbourhood Team will have four protected training days per year. The role of a Neighbourhood officer is recognised as a specialised role that requires this investment to ensure continuing professional development.

## **OPCC Delivery**

The OPCC's newly recruited **Criminal Justice Advisor**, Kate Jowett, took up post during November. Kate joins us following a long career with Work Yorkshire Police, latterly as lead for Criminal Justice.

Kate's appointment will be of **great benefit** to the OPCC in supporting delivery of key policy areas in criminal justice, and will help to **strengthen** our work with partners for the benefit of West Yorkshire communities.

I held a major partnership conference in November with a focus to help divert young people and vulnerable individuals away from harm and potential criminal behaviour. Dozens of third sector organisations and groups came together for the event in Leeds. The themes that were discussed included drugs and alcohol, mental health, adverse childhood experiences, multiple and complex needs, as well as domestic and sexual abuse. The continuing austerity and funding challenges across public sector organisations is translating to further pressures upon third sector groups, who are increasingly left to fill the gaps. A collective approach to early intervention and prevention is crucial to providing services that deliver better community safety outcomes.

## West Yorkshire Partners' Delivery

The Local Criminal Justice Board is currently reviewing drug testing of those in custody or involved in the Integrated Offender Management programme – substance abuse being one of the factors which can lead someone to reoffend after release from custody. Poor mental health is another factor, and West Yorkshire Police's safeguarding unit are to submit a research proposal to the N8 consortium of northern universities for an evaluation of the mental health nurse triage programme run from police control rooms. OPCC funding for this project in Leeds and Bradford has allowed better decision-making about the most appropriate care response for people experiencing mental ill-health. This project will independently evaluate the service with a view to sharing best practice across the N8 partnership.

An affordable legal service for **victims of domestic abuse** was launched in November. I have helped to fund the service by Bradford based charity, **Staying Put**. Affordable Legal Services will offer legal advice to all victims of domestic abuse who are not eligible for Legal Aid. 
## **OPCC Delivery**

A key strategic goal in our work to reduce crime in our neighbourhoods is the task of reducing reoffending. This calls on the co-ordination of a range of partners, many of whom are linked through the West Yorkshire Local Criminal Justice Board (LCJB). With the advent of major reforms within the criminal justice system (including across probation, courts and prison services), the **Reducing Reoffending Board** have developed a new strategy which highlights the need for partners to lead on early identification of those at risk, to have the right pathways in place, and to address the specific needs of women in the criminal justice system.

Barriers to performance and joint-working were discussed at December's Reducing Reoffending **Workshop event** coordinated by the OPCC. Issues discussed on the day included the quality of oversight provided by CRC providers, the need to co-ordinate benefits, accommodation, and health care needs for prison leavers, and the pressure to find suitable accommodation. This final point is particularly pertinent for West Yorkshire with HMP Leeds now reclassified as a resettlement prison.

## Objective: More victims will be satisfied with the level of service they receive from the police



#### Commentary

In our Delivery Quarterly indicator of victim satisfaction with WYP's service (covering burglary, violent crime, vehicle crime, hate, and domestic abuse), 73.8% of victims recorded they were satisfied in the 12 months to December 2018, representing close to a 2 percentage point fall over 12 months. The force's new indicator covering all crime types records a higher value of 74.8% satisfied (to Dec. 18). [\*Victims are now only asked to comment on services they have received, and the district data in the table above is collated under this new methodology.]

## Objective: More victims who choose to access victims' services will be satisfied with the service they receive




#### Commentary

Victim Support had a caseload of 1532 victims during Q3 2018/19. Roughly 40% of these cases are related to instances of domestic abuse.

Victim Support's services help victims by arranging peer support, building self-confidence, and assistance with low cost security devices like personal alarms. Upon accessing the service, victims are asked to score four statements on a scale of 1 to 10 to assess their perception of safety. At the end of their period of support they are asked again to score their sense of wellbeing to measure the 'distance travelled'. The graph reflects the proportion of service users who felt their situation had improved at the end of their period of support. This data is supplied to the Ministry of Justice and is refreshed every six months

## Commentary

West Yorkshire Police's survey of victims' satisfaction with the outcome of their case covers burglary, vehicle crime, criminal damage, arson, robbery, theft, violence against the person, and hate incidents. In the year to December 2018, 61.2% of victims said they were satisfied with the outcome of their case, meaning this indicator has remained stable since the last quarter.

SUPPORT VICTIMS AND WITNESSES DELIVERY OVERVIEW

### West Yorkshire Police Delivery

A N8 universities project is examining the possibility of the early Identification of **Honour Based Abuse**. The work is progressing well, with WYP data being analysed by the research team from the University of Manchester, to look at missed opportunities. The **next phase** of the project involves interviews with **key stakeholders and victims**, with dissemination events for the results of the research planned for May 2019.

West Yorkshire Police are part of a national pilot project focusing on **Cyber crime**. The project aims to ensure 100% of cyber crime reports have a Pursue investigation and 100% of victims receive bespoke support from policing. This has secured **national funding** which is paying for increases in staffing, training and equipment on the team. This has seen the creation of dedicated Cyber protection and Cyber prevention officers who have recently started in post. They are already engaging and working with key partners across the Force to prevent young people from becoming a cyber-criminal and protect people and business from becoming victims.

## **OPCC Delivery**

Volunteers from Victim Support West Yorkshire have been honoured for their role in helping victims of the Manchester Attack. The volunteers provided support to 117 victims from West Yorkshire who were caught up in the incident in 2017 and received the OPCC Volunteer Awards at the Lord Ferrers Awards held in London. Volunteers provided emotional and practical support to those directly affected by the incident, but also to family members who witnessed the incident.

Victim Support earlier this year were also chosen to continue to provide my **core support services** to victims and witnesses for the next three years across West Yorkshire. This includes an expanded service which now involves under 18 year's olds for the first time and a live chat facility via their website to make contact even easier and convenient

I called for a victim-centred approach to tackling modern slavery whilst giving evidence to the Home Affairs Select Committee as part of its Modern Slavery inquiry. I talked about the need for more collaborative working, greater care for victims and survivors, as well as additional resources and training

Here in West Yorkshire, under my Safer Communities Fund, I have also provided over £75,000 to 17 separate local organisations, which work specifically to address and tackle these important issues.

## West Yorkshire Partners' Delivery

An innovative animation specifically designed to **safeguard children** from exploitation and abuse premiered in January at the National Media Museum in Bradford. Called **'Mister Shapeshifter**', the project has received £36,000 from the OPCC. It uses a modern 'fairy tale' to depict how some adults can abuse children's trust and highlights ways in which children can protect themselves against risk and danger in real life and online. The resource is supported by a free to access package of training materials designed to help teachers, parents and community groups to discuss these complex issues and deliver a consistent message to children.

West Yorkshire Police have launched a public facing campaign to publicise Clare's Law (the domestic violence disclosure scheme). Members of the public can approach the police for information on their partner's domestic violence history in certain circumstances under the 'right to ask' criteria. It is hoped that the campaign will lead to an increase in the number of applications received by police

## **OPCC Delivery**

The final months of 2018 saw significant progress in the development of the **Victims** and **Witnesses Strategy**. A draft strategy has been circulated to partners (for example, the LCJB Victims and Witnesses Group) with a further draft to be presented to the LCJB Executive in March.

Unfortunately, a West Yorkshire bid to the Home Office's 'Children Affected by Domestic Abuse Fund' was unsuccessful, however another West Yorkshire bid to the Ministry of Housing, Communities & Local Government for additional Independent **Domestic Violence Advisor** (IDVA) capacity was successful, and will fund the new service for two years between 2018 and 2020. We hope to be able to make a further announcement on the extension of the West Yorkshire Independent **Sexual Violence Advisor** (ISVA) service in March.

Work with West Yorkshire Police has progressed during the quarter, especially in respect of the **interface** between the police and our OPCC commissioned victim and **restorative justice services**. However further work is still needed to clarify the corporate ownership of the victim's agenda within the police service.
